UW-Madison Division of Extension Langlade County is presenting the Tractor & Machinery Safety Course for youth ages 12-13-year old who may need a federal certificate of training to legally drive farm machinery on public roads in Wisconsin, only when working for their parents or grandparent's.

In Wisconsin, 14 and 15 year-olds who have successfully passed the Wisconsin Safe Operation of Tractor and Farm Machinery Course can legally drive farm machinery on public roads for their parents or grandparents' farms AND can work for other farms and do the same. 12 and 13-year old who have completed the course can legally drive farm machinery on public roads only when working for their parents or grandparents' farms. If you employ persons under 15 years or who do not have a driver's license, it is highly recommended that you have them attend the training, whether they drive on public roads or not.

Note: If employed under 15 years or who do not have a driver's license, it is highly recommended that you have them attend the training, whether they drive on public roads or not. You may want to talk with employers about double-checking their insurance policy on requirements.

Youth Tractor & Machinery Safety Certification Course

This 24-hour program meets the requirements of Wisconsin Act 455, which requires youth under the age of 16 to hold a certificate of training in order to operate any type of farm equipment on a public road. It also meets the child labor requirements in agriculture under the Fair Labor Standards Act, pertaining to the employment of youth ages 14-15 on farms not operated by their parents or guardians.

The fee for this class is Langlade County Farms or Residents Free, Non-Residents \$40 per youth, which includes the training manual and handouts.
